APPEAL FOR READMISSION

Students who have been academically dismissed from the University are not readmitted until they have produced evidence that they can further pursue academic work satisfactorily. The university normally requires that students improve their term or cumulative grade-point average (through work in Summer Session) to a level which would have precluded drop action. Each case is considered on its merits.

Readmission is denied to those students who, once separated from the University, have such low cumulative grade-point averages that ultimate graduation appears improbable. Students are not usually readmitted after a second drop action. The student should keep in mind that only grades earned in the various colleges of the University may be included in the Rutgers cumulative grade-point average.

NOTE: Some programs have special academic standards in addition to the conditions of admission to the Camden College of Arts & Sciences and University College. If the Scholastic Standing Committee decides in favor of readmission, this decision applies to admission to the **Camden College of Arts and Sciences or University College only**. It does not imply admissibility to a particular professional program.
