RE-ENROLLMENT

The following forms are to be used by former Rutgers University-Camden students wanting to return to their last college of attendance, or seeking a second bachelor's degree. It must be noted that permission to re-enroll does not guarantee admissions to specific major programs. Some departments require separate approval. Please complete the application and the personal data form.

Students who have been dismissed should contact the Learning Center. If you have already been approved for readmission, attach a copy of your letter from the Scholastic Standing Committee. All academic dismissals and financial obligations must be cleared before re-enrollment will be permitted. Failure to do so will result in the immediate termination of your registration.

CONDITIONS

NON-MATRICULATED STUDENTS

Non-Matriculated students are permitted to take a maximum 30 credits. To matriculate, contact the Office of Admissions at (856) 225-6104.

SCHOLASTIC STANDING COMMITTEE CONDITIONS

If you were on Scholastic Probation and/or scholastically dismissed, the Scholastic Standing Committee may have placed conditions on you while you were in attendance at Rutgers previously, these conditions are still in effect and must be fulfilled immediately upon return.
